August 22, 1971 - November 28, 2015

Abraham “Abe” DeVol, 44, Kalkaska County Sheriff, passed away unexpectedly on Saturday, November 28, 2015. He was born on August 22, 1971 in Traverse City to Robert and Betty (Clifton) DeVol. Abe attended the NMC Police Academy and began his police career in 1995 as a Marine/Snowmobile Officer and was hired in 1996 as a full time deputy at Kalkaska County Sheriff Department. Abe was the Undersheriff for Kalkaska County from 2009 until March 1, 2015 when he was appointed Sheriff. He was a member of the MI Sheriffs Assoc., Kiwanis’s, ERT Team Director, and Northern Michigan Mutual AID. Abe also graduated in 2014 from the FBI Academy. Abe was an instructor at Kirtland Police Academy. Abe married Anne Reiniche on July 31, 1999 in Jackson. Together they raised their twin daughters in Clearwater Township. Abe enjoyed hunting, fishing, golfing, coaching softball, boating on Torch and participating in whatever sports the girls were involved in. His love of the “outdoors” was only surpassed by his love for his wife and girls. He was extremely dedicated to the community he served.
