October 20, 1950 - January 14, 2012

Brian F. Donnelly, 61, of Kalamazoo County, passed away unexpectedly on Saturday, January 14, 2012 while skiing on the VASA Trail in Grand Traverse County. He was born on October 20, 1950 in Plymouth to the late Mac J. and Elizabeth Anne (DeWaele) Donnelly. Brian married Ruthann R. O'Brien on July 16, 1987 in Kalamazoo. They have resided in Kalamazoo County since 1995. Brian graduated from the University of Michigan Law School. He was a member of the Michigan Prosecuting Attorneys Association. Brian was a dedicated prosecutor for 25 years, honorably serving the citizens of Kalamazoo, Grand Traverse, and Kalamazoo Counties. His deep commitment to his community will be deeply missed. He loved Michigan outdoor activities which included skiing, hiking, fishing, kayaking, hunting, and walking his dog Lizzie. Brian is survived by his loving wife of 24 years, Ruthann; his dear siblings, Kathleen Martin of Troy, Mary (Hal) Smith of Overland Park, Kansas, Tom Donnelly of Canton, and Elizabeth (Dick) Barker of Plymouth; his sister-in-law, Margie Thornton of Williamston; and many nieces and nephews. He was preceded in death by his parents; his brother Mac Donnelly, Jr. who was killed in the line of duty during a bank robbery in Lansing making him the first Lansing police officer to die in the line of duty; and his sister Gail Drouillard. 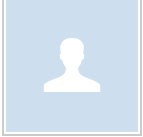
